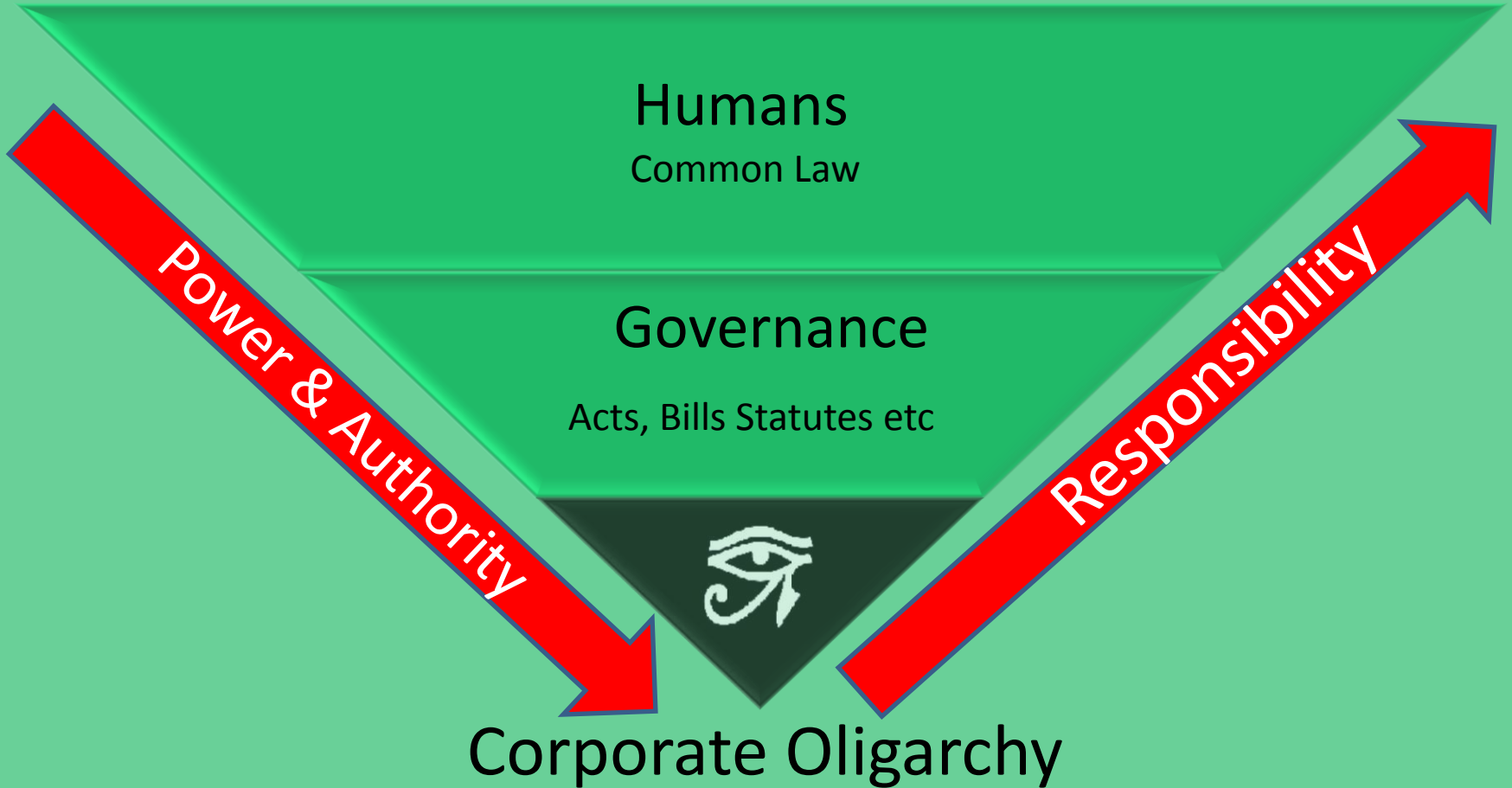

# Legalese

**This is the language the legal system is based on.**

You are the illiterate person and hence they force a lawyer / solicitor / defender on you failing which they cannot proceed as they know you do not speak the legal language... The have morals!

# Definition of COLOR

Blacks Law Dictionary 4<sup>th</sup> ed. p331

**An appearance, semblance, or simulacrum, as distinguished from that which is real.**

NO LEGAL DEFINITION OF SIMULACRUM!

**Sim•u•la•crum** (sĭm ,yə-lā'krəm, -lăk'rəm) ►

*n.* An image or representation.

*n.* An unreal or vague semblance.

# Definition of COLOR OF AUTHORITY

Blacks Law Dictionary 4<sup>th</sup> ed. p331

**An act unjustly done by the countenance (Also encouraging, aiding and abetting p 419) of an office, being grounded upon corruption, to which the office is a shadow and color.**

# Definition of COLOR OF LAW

Blacks Law Dictionary 4<sup>th</sup> ed. p331

**The appearance or semblance,  
without the substance of legal  
right.**

# Definition of COLOR OF TITLE

Blacks Law Dictionary 4<sup>th</sup> ed. p332

**That which the law considers *prima facie* (at first sight p1353) a good title, but which, by reason of some defect, not appearing on its face, does not in fact amount to title**

# LARCENY

larceny (lɑːrʃəni )

uncountable noun. Larceny is the crime of stealing.

Blacks Law Dictionary 4<sup>th</sup> ed. p1023

**LARCENY. .... Is fraudulent taking and carrying away of a thing without claim of right, with the intention of converting it to a use other than that of the owner, without his consent. ...**



# CONSENT

## consent

*v.* To give assent, as to the proposal of another; agree.

*v. Archaic* To be of the same mind or opinion.

*n.* Acceptance or approval of what is planned or done by another; acquiescence. See Synonyms at [permission](#).

Blacks Law Dictionary 4<sup>th</sup> ed. P377

**A concurrence of wills. Voluntarily yielding the will to the proposition of another; acquiescence or compliance therewith.**

**Agreement; the act or result of coming into harmony or accord**

**..... Is an act of reason, accompanied with deliberation, the mind weighing as in a balance the good or evil on each side. ...**

# TACIT

## **tacit**

*adj.* Not spoken: *indicated tacit approval by smiling and winking.*

*adj.* Implied by or inferred from actions or statements:

*adj. Law* Arising by operation of the law rather than through direct expression.

**Existing, inferred, or understood without being openly expressed or stated, implied by silence or silent acquiescence, understood, implied as tacit agreement.....**

**Manifested by the refraining from contradiction or objection; .....**

# TACIT CONSENT

**As consent is a meeting of the minds, and tacit is an assumption of agreement, the phrase TACIT CONSENT is an oxymoron, an impossibility, and hence as justification of actions is unlawful!**

# Knowingly causing harm is **UNLAWFUL CONTRACT**

Hence anything pretending to be something it is not, is by intent designed (hence knowingly) to cause harm, and hence is **unlawful!**

# Hence “Public Bodies” belong to the people

All governments, councils, local authorities, counties, states or whatever any public service chooses to call itself belong to the people, unless they can prove a lawful contract with every person at the time giving their consent.

**Hence Birth Certificates are merely  
that!**

Birth certificates are merely a record of your birth, unless anyone claiming it or rights to it can prove a lawful contract with you giving consent to anything else!

**Hence any “registrations” are  
merely that!**

Any registration of property is merely a record of your ownership of that property, unless anyone claiming it or rights to it can prove a lawful contract with you giving consent to anything else!

**Hence any “postal systems” are  
merely that!**

Post codes and Zip code are merely a part of the public service of the postal system, unless anyone claiming it or rights to it can prove a lawful contract with you giving consent to anything else!



**Hence any “etc...” are merely that!**

They same applies to absolutely anything, unless anyone claiming it, or rights to it can prove a lawful contract with you giving consent to anything else!

# Hence “Public employees” are accountable to the people

- We have delegated them authority.
- We must uphold our responsibility that they act within the law.
- We accordingly have full access to any and every record, meeting and any other form of business at the time of our choosing!

**Hence “Public employees” are  
accountable to the people**

As we have delegated some of  
our authority for them to act  
on our behalf there can be no  
secrecy!
